Fees

Fees will be paid monthly, in advance, to be received ON or BEFORE the first session of each month. Any bank charges incurred by Firm Foundation Course for a cheque, that is not honoured, will be passed back to the individual. All scheduled sessions must be paid for unless you give Firm Foundation Course at least 2 days notice of absence. There is a 50% reduction in fees if your child is absent without prior notice unless it is due to illness.

If payment is not made by the due date, then 10% interest charge may be added. Parents who pick up their child late will incur a **late charge of £10** per half hour or part of a half hour.

Parents shall be liable to pay all costs, fees and charges including any costs reasonably incurred by Firm Foundation Course in the recovery of any unpaid tuition fees and materials.
